PROPOSITION 300

OFFICIAL TITLE

REFERENDUM ORDERED BY PETITION OF THE PEOPLE

A referendum ordered by petition of the people ordering the submission to the people for their approval or rejection that portion of agenda item 5 of the October 15, 1991 City Council agenda, specifically, authorization numbers a, b, c, d, e, and f calling for the widening and construction of 64th Street from McDowell to Indian School and other related improvements passed by the City Council on October 15, 1991.

Descriptive Title

Allow the qualified City of Scottsdale electors to approve or reject City Council's decision of October 15, 1991 authorizing widening and construction of 64th Street from McDowell to Indian School Road, widening of Indian School Road from 64th to 68th Street, and related intersection improvements and buffering treatments, without residential relocation.

A "yes" vote shall have the effect of approving City Council's decision regarding Agenda Item 5 of the October 15, 1991 Council Meeting authorizing the following:

- a) 64th Street - widen from McDowell Road to Thomas Road to a major collector cross section
- b) 64th Street - construct from Thomas Road to Indian School Road to a major collector cross section
- c) Indian School Road - widen from 64th Street to 68th Street to include a center left-turn lane
- d) Make intersection improvements to 64th Street and Thomas Road, 64th Street and Osborn Road, 64th Street and Indian School Road and Indian School Road and 68th Street
- e) Roadway improvements will occur without residential relocation
- f) Buffering treatments are to occur prior to or simultaneous with street widening

**NEW BOND AUTHORIZATION FOR
PIMA ROAD WIDENING AND
BUFFERING**

Shall the City of Scottsdale be authorized to issue and sell general obligation bonds in the principal amount of \$12,750,000 for the purpose of constructing and improving Pima Road from and including its intersection with McDowell Road to and including its intersection with Via Linda, and providing neighborhood buffering of Pima Road from and including its intersection with Fillmore Street to and including its intersection with Via Linda, and paying all expenses properly incidental thereto and to the issuance of such bonds?

The bonds will be in one or more series, will not run more than 25 years from the date thereof, and will bear interest at a rate of not to exceed 12% per annum.

PROPOSITION 400

OFFICIAL TITLE

REFERRED TO THE PEOPLE BY THE CITY COUNCIL,
PURSUANT TO ARTICLE 12, SECTION 1 OF THE CITY
CHARTER

SHALL A FRANCHISE TO OPERATE A PUBLIC UTILITY
SUPPLYING NATURAL AND ARTIFICIAL GAS TO RESIDENTS
OF THE CITY BE GRANTED TO THE BLACK MOUNTAIN GAS
COMPANY?

Descriptive Title

This proposition would authorize and direct the City Council to grant a franchise to the Black Mountain Gas Company, to operate a public utility supplying natural and artificial gas to residents of the city, in accordance with terms and conditions previously approved by the City Council.

A "Yes" vote would have the effect of authorizing and directing the City Council to grant a franchise to operate a public utility supplying natural and artificial gas to residents of the city to the Black Mountain Gas Company.
