PROPOSITION 404

REFERRED TO THE PEOPLE OF THE CITY BY THE CITY COUNCIL

OFFICIAL TITLE - SHALL THE CITY COUNCIL BE AUTHORIZED TO APPROVE BONDS TO ACQUIRE LAND FOR THE MCDOWELL SONORAN PRESERVE, TO BE PAID ONLY FROM THE PROCEEDS OF THE TWO-TENTHS (.2%) OF ONE PERCENT (1%) TRANSACTION PRIVILEGE AND USE TAX WHICH WAS APPROVED BY THE VOTERS AT THE SPECIAL ELECTION HELD ON MAY 23, 1995, FOR THE PURPOSE OF ACQUIRING SUCH LAND.

DESCRIPTIVE TITLE - THIS PROPOSITION WOULD GIVE THE CITY COUNCIL VOTER APPROVAL TO AUTHORIZE BONDS TO ACQUIRE LAND FOR THE MCDOWELL SONORAN PRESERVE, WHICH WOULD BE PAID FOR USING ONLY PROCEEDS FROM THE TRANSACTION PRIVILEGE AND USE TAX PREVIOUSLY AUTHORIZED BY VOTERS FOR SUCH LAND ACQUISITION.

A "YES" vote shall have the effect of giving the city council voter approval to authorize bonds to acquire land for the McDowell Sonoran Preserve, which would be paid for only from the transaction privilege and use tax previously approved for such purposes.

A "NO" vote shall have the effect of not giving the city council voter approval to authorize bonds to acquire land for the McDowell Sonoran Preserve.

PROPOSITION 405

REFERENDUM ORDERED BY PETITION OF THE PEOPLE

OFFICIAL TITLE - A REFERENDUM ORDERED BY PETITION OF THE PEOPLE TO APPROVE OR REJECT CITY OF SCOTTSDALE ORDINANCE NO. 2710, ENTITLED, "AN ORDINANCE OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, AMENDING ORDINANCE NO 455, THE ZONING ORDINANCE OF THE CITY OF SCOTTSDALE BY AND FOR THE PURPOSE OF CHANGING THE ZONING ON THE "DISTRICT MAP", TO ZONING APPROVED IN CASE NO. 47-ZN-94" CHANGING THE ZONING FROM R1-43 ESL (SINGLE FAMILY RESIDENTIAL / ENVIRONMENTALLY SENSITIVE LANDS) TO R1-18 ESL (SINGLE-FAMILY RESIDENTIAL / ENVIRONMENTALLY SENSITIVE LANDS).

DESCRIPTIVE TITLE - SUPPORT OR REJECT THE CITY COUNCIL'S DECISION TO CHANGE THE ALLOWED DENSITY FROM APPROXIMATELY 1.0 TO APPROXIMATELY 1.4 SINGLE FAMILY HOMES /ACRE, CONSISTENT WITH THE LAND USE ELEMENT OF SCOTTSDALE'S GENERAL PLAN, ON APPROXIMATELY 40 ACRES OF LAND AT THE SOUTHEAST CORNER OF THE CACTUS ROAD ALIGNMENT AND 132ND STREET.

A "YES" vote shall have the effect of approving the City Council's decision to adopt Ordinance 2710 which re-zones the property to R1-18 ESL (Single-Family Residential / Environmentally Sensitive Lands).

A "NO" vote shall have the effect of rejecting the City Council's decision to change the zoning approved in Ordinance 2710 and retaining, subject to possible future rezoning approvals, the currently approved zoning of R1-43 ESL (Single-Family Residential / Environmentally Sensitive Lands).
