To the Voters of the City of Scottsdale:

This pamphlet provides you with information regarding the City of Scottsdale's November 8, 2016 General/Special Election to elect a Mayor and three Councilmembers.

The Scottsdale City Council called a Special Election to run concurrently with the November 8, 2016 General Election, for the purpose of referring to the voters, as Proposition 490, a Scottsdale City Charter amendment, adopted by the Scottsdale City Council in Ordinance No. 4247.

Proposition 490 asks voters to consider an amendment to the Scottsdale City Charter. The amendment, if approved by the voters, would correct outdated Charter language to accurately reflect when: 1) Scottsdale candidate elections are held; and 2) Mayor and Councilmember terms begin.

All qualified electors of the City, regardless of party registration, may vote for one mayoral candidate, three Council candidates, and on Proposition 490.

This pamphlet contains general voting information regarding early voting and identification at the polls, the full text of the proposed measure, the tagline text that will appear on the ballot, and statements in support of and in opposition to Proposition 490. Beginning on Page 12, are statements prepared and submitted by each of the candidates for this election.

The ballot arguments and candidate statements included in this pamphlet represent the opinions of the authors and have not been edited or checked for accuracy of content.

VOTER IDENTIFICATION AT THE POLLS

Every voter is required to show proof of identity at the polling place before receiving a ballot. This is a result of Proposition 200, the statewide initiative approved by voters in 2004.

ACCEPTABLE IDENTIFICATION

Following are the types of identification that are acceptable and that can be used when voting at a polling place on Election Day. All identification must match the voter's name and address shown on the Maricopa County Elections Signature Roster.

LIST 1 – Acceptable forms of ID with voter's photograph, name, and address. The address must reasonably match the precinct register (1 required):

- Valid Arizona driver's license
- Valid Arizona non-operating identification license
- Tribal enrollment card or other form of tribal identification
- Valid United States federal, state, or local government issued identification

LIST 2 – Acceptable forms of ID (no photo) with voter's name and address. The address must reasonably match the precinct register (2 required):

- Utility bill of the elector dated within 90 days of the election (may be electric, gas, water, solid waste, sewer, telephone, cellular phone, or cable television)
- Bank or credit union statement dated within 90 days of the election
- Valid Arizona vehicle registration
- Indian census card
- Property tax statement of the elector's residence
- Tribal enrollment card or other form of tribal identification
- Arizona vehicle insurance card
- Recorder's Certificate
- Valid United States federal, state, or local government issued identification, including a voter registration card issued by the County Recorder
- Any mailing to the elector marked "Official Election Material"

LIST 3 – Acceptable forms of ID, one with photo, one without (2 required):

- Any valid photo identification from List 1 in which the address does not match the precinct register accompanied by one valid item from List 2
- United States passport without address and one valid item from List 2
- United States military identification without address and one valid item from List 2

An identification is "valid" unless it can be determined on its face that it has expired.

Other forms of identification not on this list must be deemed acceptable by the county election official in charge of elections and must establish the identity of the elector.

PROVISIONAL BALLOT

If the voter does not have acceptable identification at the polling place, a Provisional Ballot may be voted. Acceptable identification must then be presented to the City Clerk or the Maricopa County Recorder before 5:00 p.m. on Wednesday, November 16, 2016.

IMPORTANT VOTING INFORMATION

Date of Election Tuesday, November 8, 2016

Your polling place will be open from 6:00 a.m. to 7:00 p.m. To cast your vote, make sure you go to the polling place indicated on the mailing label of this pamphlet.

Pursuant to Arizona Revised Statutes, any qualified elector, at the voter’s option, may be accompanied by a minor, who is permitted in the voting booth; be accompanied and assisted by a person of the voter’s own choice; or be assisted by two election officials, during any process relating to voting or during the actual process of voting on a paper ballot, machine, or electronic voting system. A person who is a candidate for an office in that election other than the office of precinct committeeman is not eligible to assist any voter. [A.R.S. §§ 16-515(E) and 16-580(G)].

Any qualified elector who, at 7:00 p.m., is in the line of waiting voters, shall be allowed to prepare and cast a ballot.

ORDINANCE NO. 4247

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF SCOTTSDALE, ARIZONA, PROPOSING AN AMENDMENT TO THE CITY CHARTER AND SUBMITTING THE PROPOSED AMENDMENT TO A VOTE OF THE QUALIFIED ELECTORS OF THE CITY AT A SPECIAL ELECTION TO BE HELD CONCURRENTLY WITH THE AUGUST 30, 2016 PRIMARY ELECTION, OR THE NOVEMBER 8, 2016 GENERAL ELECTION IF THERE IS NO PRIMARY ELECTION.

BE IT ORDAINED by the Council of the City of Scottsdale as follows:

Section 1. The Council of the City of Scottsdale does hereby propose and submit to a vote of the qualified electors of the City, at a Special Election to be held concurrently with the August 30, 2016 Primary Election, if held, or the November 8, 2016 General Election, if there is no Primary Election, the following amendment to the Charter of the City of Scottsdale, pursuant to Article 13, Section 2, of the Constitution of the State of Arizona, and Article 16, Section 1, of the Charter of the City of Scottsdale. Text which has a line drawn through it indicates the material is proposed to be deleted or repealed. Capital letters text indicates that the material is new or proposed to be added. The proposed amendment is followed by a summary of the effect of the amendment if approved.

QUESTION 1 (PROPOSITION 490)

SHALL ARTICLE 2, SECTIONS 3 AND 9, AND ARTICLE 9, SECTION 4, OF THE SCOTTSDALE CITY CHARTER, RELATING TO THE DATES FOR HOLDING THE CITY'S PRIMARY AND GENERAL ELECTIONS, THE DATE THE MAYOR AND COUNCIL MEMBERS ARE INDUCTED INTO OFFICE, AND WHEN THE MAYOR AND COUNCIL MEMBER TERMS COMMENCE, BE AMENDED TO: (1) CLARIFY THAT THE CITY'S PRIMARY ELECTION SHALL BE HELD IN EVEN-NUMBERED YEARS ON THE DATE SET FOR THE STATE'S PRIMARY ELECTION, AND THE DATE FOR HOLDING THE CITY'S GENERAL ELECTION SHALL BE HELD IN EVEN- NUMBERED YEARS ON THE DATE SET FOR THE STATE'S GENERAL ELECTION; AND (2) ESTABLISH THAT THE MAYOR AND COUNCIL MEMBER TERMS SHALL COMMENCE AT THE FIRST REGULAR MEETING OF THE COUNCIL IN JANUARY OF THE YEAR FOLLOWING THEIR ELECTION?

Art. 2, Sec. 3. Terms of mayor and council members.

UNLESS OTHERWISE PROVIDED BY THE ARIZONA CONSTITUTION OR LAWS OF THIS STATE, ~~the~~ terms of the mayor and each member of the council shall commence at the first regular meeting of the council IN JANUARY OF THE YEAR following the date set for the general election, even if no such general election is held, and shall be for four consecutive years thereafter, or until his or her successor is duly elected and inducted into office. ~~The mayor and three members of the council shall be elected in the year 2000, and three members of the council shall be elected two years thereafter.~~

Art. 2, Sec. 9. Induction of mayor and council into office.

UNLESS OTHERWISE PROVIDED BY THE ARIZONA CONSTITUTION OR LAWS OF THIS STATE, ~~E~~each newly elected mayor and member of the council shall be inducted into office at the beginning of the first regular meeting of the council IN JANUARY OF THE YEAR following the date set for the general election, even if no general election is held.

Art. 9, Sec. 4. Time of holding primary elections.

Primary elections shall be held in even-numbered years on the ~~first calendar date authorized by the state law establishing mandatory election dates. If there is no such law, or if the state law is made optional or is determined not to be mandatory for charter cities, then the primary election shall be held on the third Tuesday in February.~~ DATE SET FOR THE STATE'S PRIMARY ELECTION. General elections, if

necessary, shall be held following primary elections ~~on the second calendar date authorized by the state law establishing mandatory election dates. If there is no such law, or if the state law is made optional or is determined not to be mandatory for charter cities, then the general shall be held on the fourth Tuesday in March.~~ IN EVEN-NUMBERED YEARS ON THE DATE SET FOR THE STATE'S GENERAL ELECTION.

Descriptive title

This proposition corrects outdated language in the City Charter to clarify that the city's primary and general elections are held concurrently with the State's primary and general elections, and conforms the commencement date of the terms of the mayor and each member of the council with current practice.

Effect of amendment:

A "yes" vote shall have the effect of correcting outdated language in the City Charter by clarifying that the city's primary and general elections are held concurrently with the State's primary and general elections, in conformance with State law, and that the terms of the mayor and each member of the council shall commence at the first regular meeting of the Council in January of the year following their election, in conformance with current practice.

A "no" vote shall have the effect of retaining the outdated charter language regarding the dates for holding the city's primary and general elections and the date the mayor and the council member terms commence.

Section 2. Form of ballot. The form, numbering and ballot language for the proposed amendment shall be determined by the city clerk, with the assistance of the city attorney, as provided by state statute, or as otherwise provided by law.

Section 3. Election date. Question 1, contained in this ordinance, will be placed on the August 30, 2016 Primary Election ballot if such an election is held. Otherwise, Question 1 will be placed on the November 8, 2016 General Election ballot.

Section 4. Severability. The provisions of this ordinance are severable and if any provision, sentence, clause, section, question, or part hereof shall be held illegal, invalid or unconstitutional, such illegality, invalidity or unconstitutionality shall not affect or impair any of the remaining provisions, sentences, clauses, sections, questions or parts of this ordinance. It is hereby declared to be the legislative intent of this ordinance that this ordinance would have been adopted if such illegal, invalid, or unconstitutional provision, sentence, clause, section, question or part had not been included herein.

**PROPOSED AMENDMENT TO THE SCOTTSDALE CITY CHARTER
BY THE CITY COUNCIL**

OFFICIAL TITLE: SHALL ARTICLE 2, SECTIONS 3 AND 9, AND ARTICLE 9, SECTION 4, OF THE SCOTTSDALE CITY CHARTER, RELATING TO THE DATES FOR HOLDING THE CITY'S PRIMARY AND GENERAL ELECTIONS, THE DATE THE MAYOR AND COUNCIL MEMBERS ARE INDUCTED INTO OFFICE, AND WHEN THE MAYOR AND COUNCIL MEMBER TERMS COMMENCE, BE AMENDED TO: (1) CLARIFY THAT THE CITY'S PRIMARY ELECTION SHALL BE HELD IN EVEN-NUMBERED YEARS ON THE DATE SET FOR THE STATE'S PRIMARY ELECTION, AND THE DATE FOR HOLDING THE CITY'S GENERAL ELECTION SHALL BE HELD IN EVEN-NUMBERED YEARS ON THE DATE SET FOR THE STATE'S GENERAL ELECTION; AND (2) ESTABLISH THAT THE MAYOR AND COUNCIL MEMBER TERMS SHALL COMMENCE AT THE FIRST REGULAR MEETING OF THE COUNCIL IN JANUARY OF THE YEAR FOLLOWING THEIR ELECTION?

ARGUMENT “FOR” PROPOSITION 490

Since first being elected as the Mayor of our great City in 2008, I have advocated for changes to the Scottsdale City Charter to ensure that it remains relevant and responsive to all of our citizens. It simply corrects outdated language so that any citizen who reads our Charter will know when our candidate elections are held and when newly elected Councilmembers are seated.

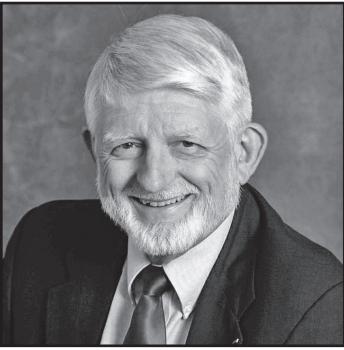
