On February 7, 2024, Speak Up Scottsdale launch two Annual Action Plan activities.

- Action Plan Discussion
 - 59 participants, which 57 discussion comments were included
- Action Plan Poll
 - 91 participants
- Both the discussion and poll closed on March 9, 2024, 12 am.










SUS COMMUNITY'S THOUGHTS ON SCOTTSDALE ANNUAL ACTION PLAN

Members were asked to consider the following statements:

- Funding non-profit agencies who provide assistance in the areas of homelessness, disabilities, seniors, and crisis case management
- Helping qualified homeowners make emergency repairs to their home in the areas of plumbing, electricity, heat, air conditioning, ADA accessibility or replacing roofs.
- · Re-paving weathered roads in qualifying areas.
- Addressing climate control and energy efficiency in qualifying areas.
- Rental housing acquisition for low-moderate income individuals and families.
- Tenant based rental assistance to seniors and homeless.
- Replacing playground equipment in parks in qualifying areas.
- Housing study that includes actionable items to increase affordable housing at 60% of the area median income.
- Technical assistance and training to local businesses with five or fewer employees.




DISCUSSION ASSESSMENT

Assessment of the discussion revealed these points:

- Community members want practical and immediate solutions.
- Preference for essential services, such as infrastructure
 maintenance and direct aid to homeowners and renters in distress.
- Skepticism towards long-term, indirect benefit initiatives like studies or large-scale project funding.
- Overall sentiment of fiscal conservatism, favoring careful spending and economizing measures.
- Demand for greater transparency in government decisions and allocations.
- Generally, skepticism towards government intervention in markets and funding of non-profit organizations.

Number of Themes Related to Funding Item










ANNUAL ACTION PLAN POLL

91 SUS members responded to the Annual Action Plan Poll.

Members were instructed to review 8 categories for funding and choose 3 that were most appealing.

- 59 Tenant Based Rental Assistance for seniors and homeless
- 59 Emergency Repair for low- and moderate-income homeowners
- 55 Rental Housing Acquisition for low- and moderate-income individuals and families
